## **ENTRY REQUIREMENTS**

### **Important Note**

The following requirements do not fully replicate the ISU requirements for skaters wishing to represent Great Britain Internationally. Additional criteria apply - please refer to ISU General Regulations 2014 and ISU Communication 1420 and any subsequent ISU Communications

For legal ruling regarding British Residency and Citizenship, skaters should contact the Home Office or if abroad the relevant British Consulate.

#### ***Skaters must meet the following requirements:***

- NISA eligible (Full or Retained) members
- Skaters who are British citizens **OR** skaters who have legally resided in Great Britain or Northern Ireland for at least one year, but are citizens of another country.
- In the Pairs and Dance events, one partner of the Pair or Dance couple must be a British citizen. The other partner of the Pair or Dance couple may be a citizen or resident of another country.
- Age qualified:
  - Basic Novice A Singles –Must not have reached 13 years before 1<sup>st</sup> July 2015
  - Basic Novice B Singles –Must not have reached 15 years before 1<sup>st</sup> July 2015
  - Advanced Novice Singles - Must not have reached 15 years before 1<sup>st</sup> July 2015
  - Junior Singles - Must not have reached 19 years before 1<sup>st</sup> July 2015
  - No age restrictions for Senior Singles and all Pairs and Dance events.

### **Anti Doping**

For all skaters over 18 years of age, it is a condition of entry to all events and competitions sanctioned by NISA permit, that they are willing to participate in anti-doping testing at that event. Parents \ Guardians of skaters under 18 are required to sign the Parental consent Form Below.

### **Warm Up Rule**

NISA reserves the right to invite additional skaters who do not automatically qualify from the ranking lists to fill up vacant spaces in warm up groups.

Guest skaters may be allowed at NISA's discretion.

There will be no automatic entry to the Championships for previous champions at the same level or champions from the level immediately below. Single skaters may **only** choose to compete in **one Singles Championship**. This does not preclude a single skater from also competing in Pairs and/or Dance if qualified to do so. Skaters/teams, who obtain a place in the first three in a Junior or Senior Championships, may not revert back to the Novice or Junior Championships respectively but may compete again at the same level subject to meeting all other requirements.
