IMPORTANT INFORMATION

Skaters may only compete in one Championship in each season. Therefore, a skater who enters the British Adult Championships (i.e. Adult Nationals) is not eligible to skate in the British Solo Ice Dance Championships, or vice versa. For the sake of clarity, however, there is no restriction on skaters participating in Open Competitions in both Adult and Solo Dance categories.

Where reference is made to 'ISU Solo Dance Requirements', this refers to the latest ISU communications published on the ISU website containing the ISU Solo Dance criteria and technical rules, as amended from time-to-time. It is the responsibility of the skater/coach to ensure they are up to date with the latest ISU communications and any updates to those communications.

The Ice Dance TAC would like to draw particular attention to the Senior age requirement for the British Solo Ice Dance Championships 2024, which has been increased to 16 in line with ISU Rule 108, para 3(a)(ii).

Please note that the Ice Dance TAC propose to further increase the age requirement to 17 in the 2024/2025 season to reflect ISU Rule 108, para 3(a)(iii).

NOTE: Beginner - Advanced Novice Pattern Dance Requirements: At Solo Dance Series Qualifier Events, one (1) Pattern Dance will be skated. The Pattern Dance will be drawn at the same time as the starting order and announced by the organising committee. At the British Solo Ice Dance Championships 2024, two (2) Pattern Dances will be skated.

1.1 GENERAL INFORMATION

Entry Criteria - Solo Dance Series Qualifier Events

- There are no mandatory age or test restrictions in any category, all skaters may compete at any level they wish to compete at.
- Women and Men will be combined for all levels.

Entry Criteria - British Solo Ice Dance Championships 2024

- All skaters must meet the age and test requirements as set out below.
- All skaters must have competed in at least one of the solo dance series qualifier events in the same category they plan to compete in at the British Solo Ice Dance Championships.
- Following the end of the solo dance series qualifier events, the top 24 skaters from each category in the national standings will qualify for the British Solo Ice Dance Championships.
- The national standings will be calculated based upon each skater's best overall score obtained at any of the solo dance series qualifier events in the 2023/24 season and skaters will be ranked accordingly.
- If two or more skaters have the same result, the Total Elements Score will break the tie in the Rhythm Dance and Pattern Dance(s). The Program Components Score will break the tie in the Free Dance. If these results are also equal, the Skaters concerned will be considered as tied.
- Women and Men will be combined for all levels.

2.1 PATTERN DANCE INFORMATION

All Pattern Dances will be skated in the order listed and must be performed with the first sequence executed in front of the judges' stand. If not, the Referee will stop the skater and instruct them to restart on the correct side without deduction. The first Step of the dance must be on beat 1 of a measure.

Skaters shall provide their own music for all Pattern Dances. Beginner and Juvenile Pattern Dance Music is ISU Ice Dance Music and will be played in order of skate tunes 1-5. For Basic Novice and above, please refer to the ISU Solo Dance Requirements.

Each skater's music for the official practice will be played for both Pattern Dances (Each skater skates the first Pattern Dance to their own music and then each skater skates the second dance to their own music)

Warm-up 2 minutes, max 6 skaters. The first 30 seconds are without music, followed by 1 minutes and 30 seconds of the 6th tune of the ISU Ice Dance music has to be played.

After the completion of the last step of the Pattern Dance, the skater must reach their final pose within 20 seconds. If this time limit is exceeded, a "Pattern Dances Program time" deduction according to Rule 353, paragraph 1. n) shall apply. The music must be chosen in accordance with the Rhythm of the Pattern Dance and may be vocal. The Tempo throughout the required Sequences must be constant and in accordance with the required Tempo of the Pattern Dance plus or minus 2 beats per minute (for dances with 4/4 timing) and plus or minus 3 beats per minute for waltz rhythms.

6.1 DEFINITIONS OF CHOREOGRAPHIC ELEMENTS – YOUNG STARS BEGINNER AND JUVENILE

Choreographic Spinning Movement: Can be performed anywhere in the program, A continuous spinning (rotating) movement with at least 3 full rotations which may be stationary or travelling. The following requirements apply:

- On two feet, or alternate feet, or one foot and one knee/boot (but not two knees).
- If a skater performs a pause within the first three (3) rotations of the spinning movement, the movement is considered broken and will not be confirmed by the Technical Panel.
- Must not meet the requirements for a Dance Spin (i.e. 3 revolutions on the spot on one foot).

Choreographic Sliding Movement: Performed anywhere in the program, during which the skater performs a controlled sliding movement on the ice.

The following requirements apply:

- Continuous controlled sliding movement on any part of the body for at least 2 seconds.
- Controlled Sliding on 2 knees or any part of the body will not be considered as a Fall/Illegal Element by the Technical Panel during this element.
- Sliding Movement which finishes as a stop on 2 knees or sitting/lying on the ice is identified as a Choreographic Sliding Movement and a deduction for Fall/Illegal Element is applied.
- Performing basic lunge movement will NOT be considered as a Choreographic Sliding Movement.

Choreographic Twizzling Movement: A Choreographic Twizzling Movement must be performed after the required Set of Twizzles. It is composed of 2 parts and the following requirements apply:

- for both parts: on one foot or two feet or a combination of both and must travel
- for the first part: at least 2 continuous rotations must be performed
- for the second part: at least 2 continuous rotations with up to 3 steps between the first and second twizzling movement

Choreographic Character Step Sequence

The following requirements apply:

- Performed anywhere in the program.
- Must begin with the skater coming within two meters (6 feet) of the barrier on either side of the rink.
- Must be placed around either the Short Axis or Long Axis and must proceed from barrier to barrier. The requirement from barrier to barrier is fulfilled when the skater is not more than 2 meters from the barrier on each side.
- Touching the ice with any part(s) of the body with controlled movements are allowed in the Character Step Sequence for Advanced Novice, Junior and Senior **only**. (example on two knees. Using both hands, etc).
- Touching the barrier at the start **or** finish is also permitted.
- Permitted stops must not be longer than 5 seconds each.
- Retrogressions are not permitted.
- Dance Spins and Edge Elements are not permitted.

Choreographic Hydroblading Movement: performed anywhere in the program, during which the skater performs hydroblading movements.

The following requirements apply:

- A low movement with the upper body almost parallel to the ice. The core of the body must be clearly positioned away from the vertical axis. No other part of the body other than the boot of the free leg is allowed to touch the ice.
- If any other part of the body (other than the allowable boot/foot drag of the free leg) touches the ice it may be considered a Chorographic Sliding Movement.
- Movement must be established by the skater for at least 2 seconds. Note: Beginner and Juvenile only
