Team Leader representing Canada and GB at International SYS events and two ISU World Championships in Singles, Pairs and Ice Dance, I have been nominated by the ISU as OAC on two occasions and as moderator for an ISU global seminar in Frankfurt.

My comprehensive understanding of the complexities and nuances of figure skating extends across all disciplines. I am qualified at National level as judge and referee for Singles, Pairs and Ice Dance disciplines as well, which is uncommon. This experience and my ongoing relationship with all skating disciplines will help me to support the TAC and BIS' Strategic Plan, moving forward.

I have been a volunteer TAC member since December 2018 and have most recently acted as Interim Chair. I have also been a member of the Performance TAC.
