# **TERMS OF REFERENCE**

## 1. Committee Functions

- 1.1. The key functions of the BIS Membership Engagement Technical Advisory Committee ("the Membership Engagement TAC" or "the Committee") are:
  - 1.1.1. to provide advice, input and reports to the BIS Board on the Committee's field of specialisation;
  - 1.1.2. to carry out the technical advisory, technical content and delegated decision- taking functions as set out in these terms of reference;
  - 1.1.3. to support the BIS Chief Executive and Staff to deliver BIS's operational plans in the Committee's field of specialisation.
- 1.2. The terms of reference of the Membership Engagement TAC (including any relevant delegated authority) are to be approved, and reviewed annually, by the BIS Board.

## 2. Committee Membership

- 2.1. All Committee Members are to be Full Annual Members or Life Members of BIS aged 18, or over, with appropriate knowledge, skills and experience in membership engagement matters.
  - 2.1.1. The disqualifications, which apply to candidates for positions as Board Directors of BIS, under the BIS Articles of Association, are also to apply to all Committee Members of the Membership Engagement TAC.
- 2.2. Subject to Articles 8.1.1.3 and Article 8.1.1.4 the voting Committee Members of the Membership Engagement TAC are to be:
  - 2.2.1.1 x individual, who is involved in a Figure Skating discipline, elected by the Voting Members of BIS;

2.2.2. 2 x individuals Who are involved in any of the following Skating disciplines, or are identified by any such designations respectively, as Figure; Speed; Inclusive Skating; Coach; Parent of a Young Skater; Adult Skater; individual member of a BIS Affiliated Club.

- 2.2.3. 1 x individual, who is an individual member of a BIS Affiliated Club, elected by the Voting Members of BIS;
- 2.2.4. 3 x individuals who are either an Adult Skater, Coach, or Parent of a Young Skater, elected by the Voting Members of BIS. More than one individual may be elected from any of these three categories, provided the overall maximum number of 3 individuals from across these categories is adhered to;
- 2.2.5.2 x members appointed by the BIS Board on an application and interview basis, and after the elections have taken place, in order to support the overall balance of skills, knowledge and experience on the Committee and taking account of the skills, knowledge and experience of the elected Committee Members.
- 2.3. The BIS member of BIS staff who has responsibility for membership engagement matters is to be the Staff Participant in meetings of the Membership Engagement TAC, but without a vote.
- 2.4. The Committee Chair of the Membership Engagement TAC is to be elected from amongst the Committee Members of the Membership Engagement TAC, on a skills and experience basis, by the Committee Members of the Membership Engagement TAC.
  - 2.4.3. The Committee Chair's primary role is to focus on effective chairing of the Committee, rather than as a discipline or function specialist, although technical knowledge and experience of membership and engagement matters will be part of the requirements of the Committee Chair's skill set.
  - 2.4.4. The appointment of the Committee Chair of the Membership Engagement TAC is subject to endorsement by the BIS Board.



- 2.4.4.1. In the interests of separation of functions, Board Directors of BIS are not eligible simultaneously to hold a position either as the Committee Chair or as a Committee Member of the Membership Engagement TAC.
- 2.4.4.2. Any individual Committee Chair or Member may only serve on one Technical Advisory Committee ("TAC") at any time, except where the Terms of Reference specify membership on a Committee as a result of being a Committee Chair or Committee Member of another TAC.
- 2.5. Each individual Committee Member may serve a maximum of two consecutive terms of office of four years each.
  - 2.5.3. In calculating the maximum terms in office, any period of an individual Committee Member's appointment to fill a casual vacancy is to be included in the calculation.
  - 2.5.4. No individual Committee Member, who has held office for the maximum number of terms allowed, is to stand for election or appointment to any TACuntil at least four years have elapsed since the completion of his maximum of terms.
- 2.6. If a casual vacancy arises on the Committee, the BIS Board is to recruit an appointee to fill the vacancy in accordance with the BIS Articles of Association.
  - 2.6.3. If the casual vacancy relates to a Committee Member elected by the Voting Members of BIS, then:
    - 2.6.3.1. the BIS Board is to seek an appointee who meets the relevant criteria set out in paragraphs 2.2.1 to 2.2.5 above; and, if no such individual can be found, then to recruit an appointee with suitable knowledge, skills and experience;
    - 2.6.3.2. the appointee is to be subject to election by the Voting Members of BIS at the next BIS General Meeting.

### 3. Committee Responsibilities

- 3.2. The Membership Engagement TAC is to have the following responsibilities (and any other responsibilities which the BIS Board may allocate to the Committee from time to time) and the delegated authority to carry out the tasks listed:
  - 3.2.3. to provide advice, input and feedback on the development and implementation of:
    - 3.2.3.1. BIS's Engagement Strategy with its membership and other stakeholders;
    - 3.2.3.2. the design of membership and stakeholder surveys;
    - 3.2.3.3. the analysis of the results of surveys designed to improve communications across BIS's membership and other stakeholder groups;
    - 3.2.3.4. the benefits packages for BIS's membership categories;
    - 3.2.3.5. proposals by the BIS Board for any Rules & Regulations which affect BIS's membership;
    - 3.2.3.6. proposals by the BIS Board for any BIS Policies which affect BIS's membership.
- 3.3. The Membership Engagement TAC does not have any budget holding responsibilities. The BIS budget allocation for activities related to membership engagement matters is held by the relevant member of BIS staff.
- 3.4. In exercising its delegated authority, the Membership Engagement TAC must only take decisions that are within the parameters of the BIS Strategic Plan, the BIS Annual Business Plan, the BIS Long Term Financial Plan, the BIS Annual Budget, and the BIS Policies that have been approved by the BIS Board.
  - 3.4.3. Any proposals by the Membership Engagement TAC for activities, which fall outside the existing BIS Plans, Budgets and Policies mentioned above, must be referred back to, and receive approval from, the BIS Board before any implementation of such activities.

### 4. Committee Proceedings

- 4.2. The Committee Members of the Membership Engagement TAC are to sign up and adhere to the BIS TAC Members' Code of Conduct including the requirements to manage conflicts of interest.
- 4.3. The Committee Chair of the Membership Engagement TAC is to call a meeting of the Committee at least 4 times each year, setting out the time, date, venue and agenda for the meeting. In the event that the



Committee Chair is absent for any reason at a time when a meeting is due, a meeting may be called by the BIS Staff Participant on the Committee.

- 4.3.3. Meetings of the Membership Engagement TAC must take place face-to-face at least once a year, but may otherwise take place by electronic means.
- 4.3.4.5 Committee Members of the Committee (including at least 4 elected Committee Members; and 1 appointed Committee Member) are required as a quorum for a meeting of the Membership Engagement TAC.
  - 4.3.4.1. In the event that the Committee Chair is absent for any reason, the Committee may choose one of its Committee Members to chair the meeting.
  - 4.3.4.2. In the event that the usual Staff Participant is absent for any reason, the Chief Executive may substitute another member of BIS staff.
- 4.3.5. Decision taking is to be usually by consensus. In the event that a vote is necessary, such vote is to be by a show of hands, with the chair of the meeting having a casting vote in the event of a tie.
- 4.3.6. The Committee Chair may invite other persons, who are not Committee Members of the Membership Engagement TAC or who are not members of BIS, to attend for specific items of Membership Engagement TAC meetings in order for such persons to share knowledge and expertise in fields which can assist the work of the Membership Engagement TAC; but such persons have no vote.
- 4.4. At least once every two years, the Membership Engagement TAC is to review its own performance and terms of reference to ensure it is operating at maximum effectiveness and to recommend any changes it considers necessary to the BIS Board for approval. This review may be undertaken at a specific Membership Engagement TAC meeting.

#### 5. Committee Reporting

- 5.2. The Committee Chair of the Membership Engagement TAC is to be a member of the BIS Operations Coordinating Group.
  - 5.2.3. In the event that the Committee Chair of the Membership Engagement TAC is unable to attend a meeting of the BIS Operations Coordinating Group, he may request another Committee Member of the Membership Engagement TAC to attend in his place.
- 5.3. The Membership Engagement TAC is to maintain written minutes of its meetings.
  - 5.3.3. The Committee Chair of the Membership Engagement TAC is to provide a written report (which may be in the form of the Membership Engagement TAC meeting minutes) to the BIS Board at least 4 times per year.
- 5.4. The BIS Board is to invite the Committee Chair of the Membership Engagement TAC to make a presentation to the BIS Board on the Committee's work at least once a year, and at such other times as the BIS Board may request.

#### 6. <u>Committee Expenses</u>

- 6.2. All Membership Engagement TAC Committee Members are to be entitled to claim travel and accommodation expenses for reimbursement in accordance with BIS's Travel & Expenses Policy.
  - 6.2.3. All expenses are to be submitted on the BIS Expenses Claim Form to the BIS office within two months of each Membership Engagement TAC Meeting.
